- Who can participate? - What is the cost? The cost for the class is \$900 and payment is due upon registration. After registration, you will receive a confirmation email with further instructions. The class size is capped to 36. Registration and payment are due 48 hours before the first date of the course.
- How will participation be documented?

A certificate of completion will be given to each participant upon completion of the program. We are working to register this class for CE's but cannot guarantee these will be available by the end of the class. If approved, CE would be available only for participation in the live portion of the class.

- Where will it be? The course will be conducted via Zoom video conference, and the Zoom link will be provided after registration.
- What is the time commitment for the course? There are 4 classes, and each class will last 3
  hours. Zoom recordings will be made available to participants who are unable to attend. (See

- How many participants will be attending? We will limit capacity for this group to 36.
- How can I participate in the discussion? Participants will have a chance to ask questions at the end of each class during Q & A time.



• What if I can't attend a class at all or for the entire duration? Each participant is allowed to have access the recordings for the class if they are unable to attend and must submit this request to training@healingrealmscenter.com. The shared Zoom recording will expire 30 days after the last live session \* and download\* is not allowed. We encourage live attendance for all sessions for maximum participation during live Q & A time.
